MR. G.P.H. WILSON

Mr. G.P.H. Wilson, a member of the University Council since 1961, has been awarded a C.M.G. in the Queen's Birthday Honours List.

Mr. Wilson has been President of the Royal Agricultural Society of Victoria since 1964.

AGREEMENT WITH LENINGRAD UNIVERSITY

An agreement has been signed to establish an exchange of scholars between Leningrad Zhdanov State University and Monash.

The agreement has been signed by the Rector of Leningrad University, Professor K.Y. Kondratyev, and Dr. Matheson and provides for the annual exchange of one senior member of staff and one postgraduate student. A senior member of staff will be sent for a period of one or two months to give lectures and the postgraduate student for ten months for research work. Provision is made in the agreement for an increase in the number of staff and postgraduate students taking part in the exchange.

Fares and travel expenses are to be paid by the sending party. The receiving party is to provide visiting scholars with living accommodation (hotel accommodation for senior members of staff and postgraduate hostel accommodation for postgraduate students) and pay them a stipend in conformity with the accepted stipends of the university in question.

Dr. Matheson said "We are all delighted with this agreement because of the great value of inter-university contacts and exchanges and we look forward to a long and fruitful relationship between our universities. Leningrad University is one of the great universities of Europe with a world-wide reputation for scholarship and research. Although the scheme will not officially commence until 1967 we have had an indication already of its value with the recent visit to both Monash and Melbourne Universities of Professor Yuri Kovalev from Leningrad who lectured here on Soviet literature."

Leningrad University was founded in 1819 by Alexander I as the University of St. Petersburg, and now has 20,000 students.

It has a similar arrangement to exchange scholars with Harvard University.

Monash is only the second Australian University to have an exchange arrangement with universities in the U.S.S.R. The Australian National University has a similar agreement with Moscow University.

APPOINTMENT OF FIRST PROFESSOR OF JAPANESE

Dr. Jiri V. Neustupny has been appointed as the first professor of Japanese. Dr. Neustupny is at present Research Associate of the Oriental Institute of the Czechoslovak Academy of Sciences, Prague.

In 1952 he entered the Philological Faculty of Charles University, Prague, specializing in Japanese and History of the Far East, and in 1957 received the degree of "promovany Milolog", which may be regarded as the equivalent of an M.A. In 1960 he completed a postgraduate course at the Oriental Institute of the Czechoslovak Academy of Sciences, where he specialized in Japanese linguistics.

Dr. Neustupny spent the following two years in the Faculty of Letters in the University of Tokyo under a scholarship programme of the Japanese government. In 1963 after returning to the Oriental Institute he was awarded the degree of "Kandidat Filologickych ved" (C.Sc. which is equivalent to a Ph.D.) by the Institute.

His research interests lie in the fields of Japanese language and literature, general linguistics (especially phonology, typology and sociology of language), and in the sociology of Japanese culture and thought. He has published a number of articles and contributions to books in these fields principally in Japanese, but also in English, Russian and Czech.

Dr. Neustupny is married and will take up his appointment in October.

APPOINTMENT OF HOWITT HALL WARDEN

Mrs. Betty Cumming, Senior Lecturer in the Department of Mathematics, has been appointed Warden of Howitt Hall. She will be the first woman in Australia to be Warden of a University Hall taking both men and women.

Howitt Hall, which is a twelve storey building, should be ready for occupation later this year and will take one hundred and eighty three students and fifteen tutors. It was named after Alfred William Howitt, a distinguished explorer, anthropologist, botanist and geologist.

Mrs. Cumming graduated Bachelor of Arts with honours in mathematics from the University of Melbourne, obtaining first class honours and the exhibitions in both pure and applied mathematics in all years of the course. She later gained the degree of Master of Arts with first class honours in mathematics.

She has been a part-time tutor and lecturer in the University of Melbourne, Trinity College and Women's College. Prior to her university positions she worked at the Aeronautical Research Laboratories.

Mrs. Cumming joined the Department of Mathematics at Monash in 1962. Her particular interests are in engineering mathematics and applied mathematics.

Since joining the staff Mrs. Cumming has been very much involved in University activities and in staff and student discussion groups.

Mrs. Cumming and her family hope to move into residence at Howitt Hall during August. She will continue her teaching responsibilities in the Department of Mathematics.

APPOINTMENTS TO READERSHIPS AND ASSOCIATE PROFESSORSHIP

Dr. G.A. Bentley (Physiology) has been promoted to an Associate Professorship.

PROFESSOR R.G.A. DE BRAY

Professor R.G.A. de Bray has accepted the invitation to occupy the Chair of Russian Language in the School of Slavonic and East European Studies, London University.

Before he came to Monash in 1963, Professor de Bray was Senior Lecturer in the Department of Russian at the University of Melbourne.

Professor de Bray was born in Leningrad and educated in England. Before his Melbourne appointment, he was Lecturer in Comparative Slavonic Philology in the School of Slavonic and East European Studies, University of London.

During the early years of the war he worked in the Uncommon Languages Department of Postal Censorship and later as language supervisor for East European Languages of the B.B.C. European Service.

Amongst Professor de Bray's chief publications is his book "Guide to the Slavonic Languages" published in 1951 and which is the first book in English to give a systematic description of the less well known Slavonic Languages.

Professor de Bray is expected to take his new position later this year.

STAFF ARRIVALS

Mr. Björn H. Jernudd - Lecturer in Linguistics - holds a filosofie kandidatexamen in phonetics and slavonic languages from the University of Uppsala in Sweden and a civilekonomexamen from the Stockholm School of Economics. He has studied linguistics at the University of Stockholm. Mr. Jernudd's main research interests are in socio-linguistics and phonetics.

Dr. P.R.V. Nayudu - Lecturer in Zoology and Comparative Physiology - graduated B.V.Sc. in 1950 and M.Sc. in 1962 from Madras University. He was awarded a Fellowship of the Royal Veterinary College of Stockholm in 1959. From 1950-62 he held various research and teaching appointments in India, first in the Madras Animal Husbandry Department and later at the Indian Veterinary Research Institute and the Postgraduate College of Animal Sciences at Izatnagar. He has recently completed a Ph.D. at Washington University, Missouri. His research interests are in the area of developmental enzymology and his doctoral thesis was entitled "Qualitative and Quantitative Genetic Differences in Alkaline Phosphomonoesterases of the Mouse Duodenum." Dr. Nayudu is married with one child.

Miss Aet Jarv - Senior Teaching Fellow in Anthropology and Sociology - graduated B.A. in 1959 from the University of Sydney. Miss Jarv then took a Diploma of Library Science at the University of New South Wales qualifying for this in 1961. After working in the Mitchell Library for two years she received an East-West Centre Fellowship at the University of Hawaii. She gained her M.A. in 1965 for a thesis on the study of kinship among two groups of immigrants in Northern Minnesota.

Mr. J.E. Fletcher - Senior Teaching Fellow in German - studied German and French at Queen Mary College, London, where he graduated B.A. (Hons.) in 1962. He has studied for brief periods at the Universities of Freiburg, Heidelburg and Kiel. In 1963 he obtained his Diploma of Education at Durham University. He then returned to Queen Mary College as an assistant in the German department where he embarked on research for the M.A. degree, the subject of which was the Baroque thinker, Athanasius Kircher. Mr. Fletcher is single.

DEPUTY WARDEN, HOWITT HALL

Applications for this position are invited from members of staff. This is a resident position. A flat, comprising a bedroom, livingroom, kitchen and bathroom is available within the Hall.

The Deputy Warden will be responsible to the Warden of the Hall and will be responsible for such administration functions as the Warden may depute to him (e.g. allocation of students to Tutors, room allocations, duty rosters, etc.) He or she will also perform all the other duties of a Hall Tutor. The Deputy Warden may be called upon by the Warden to assist in such matters as selection of student members or in acting from time to time as host to guests of the Hall. Finally, the Deputy Warden will be required to act as Warden in the Warden's absence (including study leave).

The conditions of appointment are:

- 1. The Deputy Warden may be a man or a woman, single or married. However it will not be possible to appoint anyone who has children or other dependents who would need to live in the Hall.
- The position carries with it free occupancy of the Deputy Warden's flat.
- 3. No charges will be made for electricity or heating, but a charge of \$6.00 per week will be made, entitling him to all meals in the Hall. If he is married, this charge will be \$12.00 per week, entitling him and his wife to all meals in the Hall.
- 4. These conditions will be subject to review annually and also in circumstances in which the Warden is absent from the Hall for an extended period.

Intending applicants are advised to get in touch with the Warden of Howitt Hall, Mrs. B.L. Cumming (Department of Mathematics) as soon as possible, and should, in any case, submit a written application to her by Monday, July 18th.

Rehearsals for "Hedda Gabler" are well under way. press news is of an extra performance, arranged by the Peninsula branch of the Women Graduates' Association, in aid of the Great Hall Appeal. This will be at 8.15 p.m. on Monday, July 18th in the hall of Toorak College, Mt. Eliza the Staff Drama Group's first bow outside Monash.

Meanwhile, those two battlers, A and B, were already arguing over the play.

- "A. Well, if you can't accept Hedda as a heroine with a tragic flaw - and I do rather agree that fear of scandal might seem an embarassingly petty one - how do you see her?
- B. Neither tragic nor heroic. She has an appetite for heroism if you like, but what does it all come to except heroics and decadent romanticism.
- A. Romanticism yes. But decadent?
 B. Well, if you like, I'll substitute a worse adjective. Vicarious romanticism. Hedda wants to get her thrills out of compelling others to live splendidly. All she can do for herself is 'kill time' - and initiate cruel and destructive onslaughts on the people around her. That's the troll in her. A. You don't think these people invite onslaught by the spiritual poverty of their lives? That the play is a sort of social tragedy because bourgeois society is incapable of offering Hedda any outlet or scope for her energy and intelligence, any role that she can find worth playing?
- B. Certainly one feels a good deal of sympathy with Hedda's irritation with the people around her. To be honest, I rather enjoy the sort of vicarious liberation her dialogue gives to the bitch beneath the skin. Even if it does seem more like a Viking freebooter than an aristocrat. The play does seem to reflect Ibsen's almost obsessive interest in the collision of extraordinary personalities with the everyday world. an odd one in the series because Hedda's extraordinariness is nearly all potential: this makes her rejection of ordinary society a bit thin, since it can offer courage for silly Thea, generosity for pedantic Tesman and usefulness for poor Aunt Julle.
- A. You don't find Hedda's suicide extraordinary? B. I suppose so. It's a negative sort of extraordinariness. The logical end of a drama which is a study in nay-saying. Hedda says 'no' to them all - to love, to maternity, finally to
- A. Surely her consistency compels a sort of admiration. B. It gives her a sort of dominance which one associates with But - ." heroism.

The Monash production of "Hedda Gabler", which is to run from Tuesday 12th to Saturday 16th July in the Union Hall at 8 p.m., will be unusual in that it is to be done completely in-the-round, with the action of the play taking place in a lit area in the centre of the theatre and the audience sitting on all four sides. One advantage of this kind of production is that the characters in the play are not limited by the proscenium stage convention that for most of the time they must face in one direction; another is that no member of the audience will be more than a half-dozen rows away from stage. The leading roles in this production of "Hedda Gabler" are to be played by two recent arrivals at Monash who have not previously appeared in a full production by the Staff Drama Group; Hedda Gabler is to be played by Patricia O'Sullivan,

In view of the fact that the character of the production will lessen the number of seats available in the Union Hall, and that "Hedda Gabler" is being studied by English I students, there may be full houses towards the ext of the season, and intending patrons are advised to book in advance. Tickets will be 80¢.

UNIVERSITY OF PAPUA AND NEW GUINEA

The following note on the progress of the University of Papua and New Guinea is taken from a letter written by Professor P.H. Karmel, Chairman of the Interim Council of that University. Dr. Matheson is also a member of the Interim Costocil.

"Progress to date has been unexpectedly rapid. The Interim Council held its first meeting only in October last year. This year a preliminary year of studies is being conducted at the Administrative College at Port Moresby, where fifty eight indigenous students (of whom seven are women) are undertaking studies in English, history, science and mathematics prior to their embarking on first year university work next year. This work is being conducted in makeshift quarters, but accommodation will improve towards the end of this year when some facilities in the new Administrative College become available to us. Next year first year courses will be offered in arts, law and science subjects. Students will enrol for B.A. or LL.B. degrees, but a substantial proportion of the B.A. degree may be taken in science subjects.

Dr. John Gunther has accepted the Vice-Chancellorship. have also appointed as Registrar, Mr. E.G. Kedgley, formerly Registrar of the University of New Zealand; as Deputy Registrar and Bursar, Mr. B.J. Meek, formerly of the Department of Territories; and as Librarian, Mr. W.G. Buick, formerly Associate Librarian in the Australian National University. Professor K.S. Inglis of the Australian National University has accepted the Chair of History; Professor F.C. Johnson of the Territory's Department of Education, the Chair of English; Mr. P.G. Nash of Monash University, the Chair of Law; Dr. K.P. Lamb of the University of Sydney, the Chair of Biology; Dr. D.P. Drover of the Division of Land Research of the C.S.I.R.O., the Chair of Chemistry. Appointments to the Chairs of Education, Economics, Geography, Mathematics and Social Anthropology are pending. The University has also made several appointments at lecturer and senior lecturer

The University's site comprises some 1,200 acres in the June Valley and will be used for various purposes of higher education. The site plan, which has been prepared by Mr. G.J. Harrison, Staff Architect of The Flinders University, has been completed in principle and approved by the Interim Council; and the Interim Council is now considering the means by which buildings will be designed and constructed. The first lot of University buildings proper will have to be completed by the beginning of 1969. Before then, a considerable number of houses for staff and some residential accommodation for students will have to be constructed."

ENTRY TO THE UNITED KINGDOM

Persons proceeding to the United Kingdom should be aware of the following requirements, which have been drawn to the University's attention by the United Kingdom High Commissioner in Australia.

As a consequence of the United Kingdom Commonwealth Immigrants Act, passed in 1962, persons proceeding to the United Kingdom to take up settled employment are required to obtain U.K. Ministry of Labour vouchers before leaving Australia. Application for such a voucher should be made to the British High Commission in Canberra. The procedure leading to its issue takes up to nine or ten weeks. Provided they have certain qualifications Ministry of Labour vouchers are also available to persons wishing to enter the United Kingdom without pre-arranged employment.

Those whose stay in the United Kingdom is of a temporary nature, whether in receipt of any remuneration while in Britain or not, do not require Ministry of Labour vouchers but are strongly advised by the High Commissioner to have an Entry Certificate endorsed in their passports before leaving Australia. In cases where fees are to be paid or remuneration of some kind is to be made by a United Kingdom body to the visitor evidence of the agreement or appointment should accompany an application for an Entry Certificate.

Applications for Ministry of Labour Vouchers should be addressed to the British High Commission, Canberra. Applications for Entry Certificates, should be made either to the British High Commission, Canberra, or to the British Government Office, Colonial Mutual Life Building, 330 Collins Street, Melbourne. The applicant should enclose his passport, and also evidence of employment or engagement if he is to be remunerated for services given in the United Kingdom.

DEPARTMENTAL NEWS OF GENERAL INTEREST

CHEMICAL ENGINEERING

Professor Wayne C. Edmister will be visiting Monash during the week commencing 18th July. Professor Edmister, who is well known for his published work in the fields of applied thermodynamics, distillation and petroleum processing, is at present on leave from Oklahoma State University. In addition to giving lectures to third and fourth year undergraduate students, he will address an Engineering Colloquium on the 19th July on the subject of "Thermodynamics Research and Design Applications."

At the end of July, Professor Fumitake Yoshida of Kyoto University, Japan, will arrive in Melbourne for part of an Australia-wide lecture tour organized by the Victorian Group of the Institution of Chemical Engineers. During his stay, Professor Yoshida will give a series of lectures to undergraduate and postgraduate students of Monash and Melbourne Universities, together with students of R.M.I.T., and Swinburne Technical College, on "Gas-Liquid Contact Operations." A seminar on "Chemical Engineering Aspects of the Oxygenation of Blood" has been arranged with the Department of Physiology for the 3rd August.
