Caulfield and Frankston

New Dean of Art & Design

Chisholm's new Dean of Art & Design, whose main focus is contemporary art, is also expert on areas of the culture of the ancient Middle East and Islam and recently worked as Registrar on Melbourne University's digs in Syria.

Ms Jenny Zimmer comes to Chisholm from RMIT, where she was in charge of Art History and Theory in the Department of Fine Art. At RMIT she was a member, and at one stage the Chair, of the RMIT Research Committee. She has been concerned to foster better understanding of research in the visual arts. She had been curator of numerous RMIT exhibitions and published criticism and history of the post-war visual arts in Australia. Her book *Stained Glass in Australia* was published by Oxford University Press in 1984.

She is a contributor to the National Gallery of Victoria's catalogue of the current Third Australian Sculpture Triennial, and has published widely on the visual arts in Australia.

This is the third time Jenny has started at Chisholm. She studied art for two years at one of Chisholm's precursors, Caulfield Technical College from 1959, and later joined the staff of the Caulfield Institute in 1970.

Jenny will be publishing a major essay this year on Iranian-Caucasian metal-working in the Belgian journal *Iranica Antiqua* and, prior to taking up her



appointment at Chisholm, she was researching in Turkey.



Library database can create personal manuals

A new database system currently under development in the Library will not only provide a compete listing of all periodicals, but also hold the Library procedures manual.

This unusual way of using the MicroMUMPS data retrieval system will potentially enable the Library to prepare personalised manuals for administrative personnel throughout the Institute. The periodicals will be recorded to enable budget planning, by bringing cost trends to the attention of Library staff, as well as the usual indexing functions.

The system has been developed by a number of young people on a CEP grant under the direction of Systems Librarian, David Foott. It runs on ordinary MS-DOS computers and eventually will be networked together.

'Teachers decide curriculum' —visiting Canadian lecturer

Professor James Gray, of the University of British Columbia, was a visiting Fellow at Frankston recently.

Prof Gray is a lecturer in Art Education at his home university, and of the nine weeks he spent in Australia, four were spent at the School of Education, where he gave several talks to staff and students.

In Canada, Prof Gray is conducting a study of teachers, to gain an idea of the individual nature of teaching and how art was used in conjunction with teaching practices. He extended this to Australia, looking at five secondary teachers including two in Frankston.

Prof Gray said that, in the end, 'the teachers will decide, no matter what the books or academic idealists say about education, and unless teachers are consulted on change, no change will occur'. He said that what teachers do—the quality of teachers' personalities—will override their methodology.

'When you hire a teacher, you hire a curriculum', he said.

He criticised the art/technology dichotomy, commenting that art has its own technology, and said that one of the roles of teachers is to get children to look at the visually rich world and make some sense of it.

Prof Gray visited Chisholm with his wife for one month.

New Chisholm Video on Integrating Disabled Children into Regular Schools

Up until the early part of this decade most Australian children with more than a mild disability were schooled in special institutions equipped and staffed specifically to meet their particular needs.

However, over recent years, changing social values have led to many such children being perceived to be able to work alongside their more able peers and they have been integrated into regular schools.


While some have been successfully 'mainstreamed', others have experienced considerable difficulty either in adjusting to or in being accepted into conventional schools.

This situation has prompted the production of a twenty-five minute video at Chisholm entitled Integrating Disabled Children in Regular Schools . The main purpose of the videois to encourage careful thought, debate and action on the part of individuals, groups and institutions involved in the integrating process. It achieves this by focusing on the considered opinions of key people directly involved in the schooling of disabled children namely disabled people themselves, parents and staff of special and regular schools.

The video has been devised and produced by Joe Dora, Lecturer in the School of Education at Chisholm, in conjunction with Chisholm's Educational Development Unit.

It is to be launched by the Director, Dr Geoffrey Vaughan, before an invited audience on Wednesday, 28 October at 4pm at Chisholm's Frankston Campus.

This is the second of two videos made at Chisholm on the schooling of disabled people.



The first, entitled *Education for the Disabled (Nepean School)* was released in December 1985 and has been well received both interstate and within Victoria.

Joe Dora hopes the new video will be of use not only to parents, disabled people, school councils and educators, but also to students and others who wish to develop a better understanding of disabled integration.

R&D Grants for Chisholm

State Government Grants have been made to Chisholm for two projects in a program to promote technological Research and Development in CAEs in conjunction with industry.

Chisholm made eight submissions and was successful in the first round for a project on 'Emergency Preparedness and Response Modelling System Software' supervised by Mr Arvind Shrivatava, Lecturer in Mechanical Engineering, and another project supervised by Dr Charles Osborne, on 'Zero Defects Industrial Visual Inspection Systems'. The former grant is for \$44,110 and the latter for \$30,000, out of a total available funds of \$230,000.

The Technology Program is designed to accelerate commercial development of Victoria's R&D base and the application of emerging technology to upgrade manufacturing industry to develop export oriented industries and improve education linkages.

Full Fee Overseas Students Approved

Chisholm's Council approved in principle full fee overseas (FFO) students for Chisholm, and has asked the Academic Board to develop the procedures to implement it.

The full fee idea is seen as a substantial revenue raiser, and will not disadvantage other students, according to the Director, Dr Geoff Vaughan.

In the light of the one per cent cut in recurrent funds foreshadowed in the May Mini-Budget and other financial pressures, FFO students and other initiatives must be developed by Chisholm to supplement resources and services from extraneous funds, he said.

The Institute's 1988–90 CTEC submission stated that by 1990, twenty per cent of Chisholm's total income will come from nongovernment sources, and FFO students will contribute greatly to this.

The current quotas for Australian and assisted overseas students were set by the Federal Government, and the inclusion of FFO students will not affect those places. The established right of entry of Australian students and subsidised overseas students would be protected so that Chisholm can enrol FFO students only where places cannot be filled by these other students.

Fees are to be set at a level to cover all costs of FFO students, including a capital component. Other issues to be considered by the Academic Board include the export of teaching expertise, the importation of trainee teachers and academics, and the importation of Overseas Aid students. The Board is to report to the December Meeting of the Council.

Director to meet Federal Minister

On 6 October, the Director will meet the Minister for Training, Education and Employment, John Dawkins, with Dr Brian Smith of RMIT, to discuss Doctoral Programs in CAEs, on behalf of the Victorian Conference of Principals. A preliminary meeting with Senator Button has also been arranged.

The delegation will be discussing the resources and other internal processes needed to support doctoral students, especially in the light of Mr Dawkins' recent comments on the move to industry-relevant education in CAEs and Senator Button's latest statements on the interface between tertiary institutions and industry in the areas of research, development and innovation. The SEM, a Hitachi S-2300 stateof-the-art instrument, was recently exhibited by GEC Marconi at LABEX '87 in Melbourne and attracted considerable interest. In brief, the SEM is capable of examining the surface detail of materials up to a magnification of 200,000 showing features as small as 4 nanometres or 4 millionths of a millimetre. Elemental analysis of materials will also be possible.

The instrument will find wide application in materials analysis in all areas of the Faculty including undergraduate and post-graduate courses and programs, research and consultancy.

Once the SEM is fully commissioned, an information program will be established to inform interested Faculty staff of the capabilities and applications of the instrument. A training course may be arranged for staff who envisage regular access to the SEM.

The SEM Laboratory is located in F2.14. Mr Ross Harrop (Technical Officer – Applied Physics) prepared the Laboratory and assisted in the installation of the SEM.

Knee Joint Testing

Knee Joint testing has nothing to do with X-Rays or CAT scanning on human limbs. The Chisholm Timber Engineering Technology Centre has tested several heavy structural joints by this name for use in large building construction projects.

The test is done by applying a force to the end of one leg with a 100 tonne hydraulic actuator forcing the leg inwards whilst reading the load with a load cell on the other leg and monitoring deformation at various points.

The largest Knee-joint with legs of 4.470m was tested horizontally.

Hay Classification Appeals Grounds and Procedures Developed

The Classification Appeals Committee have recently developed grounds and actions for consideration of appeals submitted by general staff against the 'Hay' classification for their position, as assigned by the General Staff Classifications Committee, The four grounds are as follows: The appellant must demonstrate to the satisfaction of the CAC that:

1. Correct Institute procedures were not followed, and/or

2. The assigned classification is inconsistent with similar internal classifications, and/or

3. Where there are no internal comparable positions, the classification is inconsistent with other similar external classifications and/or

4. During the evaluation process the position has been inappropriately classified in terms of its duties and responsiblities.

The two actions the CAC may take are as follows:

1. Uphold the appeal and request a reevaluation of the appellant's position specifying the grounds upon which the request is made, or

2. Reject the Appeal (Note-In accordance with Section 6.3.3 (xi) of the Staffing Procedures Handbook the appellant shall be sent notification outlining the reasons for such rejection).

'Chisholm will take possession, within a number of weeks, of the new nine-storey Technology Tower, which will offer some rental space to related business and industry.



Aboriginal Herbal Medicines studied at Chisholm

Chisholm is playing a pivotal role in an unusual project—the collecting of aboriginal traditional plant medicine knowledge into a Pharmacopoeia, or a reference book of plant and herbal medicines.

The project is close to Director Dr Geoff Vaughan's heart. Dr Vaughan has for some years been in contact with Dr Ella Stack, Secretary of the Northern Territory's Department of Health. Dr Stack, a well known personality in the Territory, who was the Mayor of Darwin at the time of Cyclone Tracy, is supervising the project.

The Pharmacopoeia is to be published in 1988 as a Bicentennial project, and the chemical properties of the plants collected by the NT Department of Health are being determined by scientists at Chisholm and La Trobe University.

Graduate student Tim Jackson, supervised by Dr David Hewitt and Dr Jayant Bapat of the Chemistry Department, and the Director Dr Geoff Vaughan (who has research interests in medicinal chemistry), is testing the plants for their alkaloids, which are the alkaline components of plants and are often the active substances in modern drugs. The testing of the alkaloids was originally commenced at the Victorian College of Pharmacy.

La Trobe University are testing for volatile oils in these plants, and all this information will be collated together with anecdotal information from the

Chisholm Graphic Students win Packaging Awards

Chisholm Graphic Design students have won two of the eight awards given in the National Southern Cross Packaging Design Awards for Students of 1987.

Final Year degree Graphic Design student Rosa del Weechio took out the major national prize for her packaging concept for glassware. Rosa won a return trip to Japan with \$500 spending money. This is the first time a Chisholm student has won this prestigious award in competition with Colleges of Advanced Education across Australia.

Chisholm also secured one of the remaining seven prizes of equal value, a \$250 award made to Third Year degree student Trevor Gardiner for a plant container, which answered a very difficult packaging brief.

The two winners were invited to attend the presentation by the Packaging Council of Australia at its annual conference in Sydney on 30 September.

A silver certificate of merit was also awarded to Final Year student Nick Cummins for an inventive design for the packaging of garden pegs, a good effort in the face of stiff competition.
