## AWARD OF FIRST HONORARY DEGREE

The Chancellor has announced that His Excellency the Right Honourable Lord Casey, Governor General of Australia, will be admitted to the degree of Doctor of Laws honoris causa at the conferring of degrees to be held on Saturday, 23rd April.

## HONOURS, AWARDS AND APPOINTMENTS

Professor D. Cochrane (Economics) has been appointed Chairman of Commissioners of the State Savings Bank of Victoria. He has also been appointed part-time member to the Commonwealth Bureau of Roads.

Professor B.P. Marmion (Microbiology) has been invited to be sessional chairman of a conference sponsored by the New York Academy of Science in New York, May 1966. He has also been appointed to the Board of Management of Fairfield Hospital.

## DELEGATION OF VICE-CHANCELLOR'S POWERS AND DUTIES

In order to ensure that the work of the University can continue unhindered in the absence from time to time of the Vice-Chancellor, delegation of the powers and duties of the Vice-Chancellor during such periods has been provided for in two ways:

(1) The Vice-Chancellor has been given power to delegate his statutory powers and duties by an amendment to Section 21 of the Monash University Act.

(2) The Council has resolved to delegate to a named individual, under Section 24 of the Act, such powers and duties as it has conferred or imposed on the Vice-Chancellor by resolution of Council including those implied under the title of Chief Executive Officer of the Council (save and except the power to delegate).

The individual named by Council who will act for the Vice-Chancellor in this way until 30th June is Professor D. Cochrane.

## CHAIR OF EDUCATION

Mr. S.S. Dunn has been appointed to a Chair of Education. Mr. Dunn is at present Assistant Director of the Australian Council for Educational Research.

He is a graduate of the University of Adelaide and the University of Melbourne. Since 1957 Mr. Dunn has been in charge of all test development work and associated work

carried out at the Australian Council for Educational Research. He is a part-time lecturer in "Measurement in Education", a subject in the Bachelor of Education course in the University of Melbourne. He has also given courses on aspects of applied psychology at the Royal Melbourne Institute of Technology and the Australian Institute of Management.

In 1956 he was awarded a Carnegie Grant to visit the United Kingdom and the United States of America. He visited these countries again in 1963.

Mr. Dunn has been particularly interested in examining procedures and their effects on teaching methods and on the study habits and thought processes of students. He is very interested in the development of abilities, in concept formation and in the way in which these are affected by different disciplines and teaching methods.

He is the author of some thirty papers in educational books and journals and since 1961 has been Consulting Editor of the Australian Journal of Psychology. In 1962 he was President of the Australian Branch of the British Psychological Society and since 1963 has been Chairman of its Standing Committee on the Profession of Psychology.

Mr. Dunn is married with two daughters. He is expected to take up his appointment on 1st March.

#### CHAIR OF ENGLISH

Mr. Alec King has accepted the invitation of the University Council to occupy a further Chair of English. He was previously Reader in English Literature in the University of Western Australia.

Mr. King was born in Dorset, England, and was educated at Sherborne and New College, Oxford, where he took Honour Moderations in Classics and the Final School of Literae Humaniores. While at Oxford he was a member of a poetry reading club which included Cecil Day Lewis, Rex Warner and W.H. Auden.

He is the author of the following books: 'Prose Passages' (in collaboration with Professor W. Murdoch) O.U.P., 'Everyone's Business' (a paperback on Education) O.U.P., 'Australian Holiday' an illustrated children's book on Australian Animals (in collaboration with Mrs. King), 'Control of Language' (used as a textbook at University level in India, Israel, Australia and the U.K.) Longmans Green and Co., 'Writing' (a sixth Form textbook on writing and style) Longmans Green and Co., 'Wordsworth and the Artist's Vision' (to be published early 1966), The Athlone Press.

Mr. King has contributed numerous articles and critical reviews to Australian journals and quarterlies over the past twenty-five years. He has contributed poems to Australian magazines and is at present on the editorial board of 'Westerly' and 'The Critic' and poetry editor of 'Westerley'. F.W. Cheshire Ltd. has commissioned him to write a book on Australian poetry. Mr. King has broadcast regularly for thirty years on literature, art, music and religious topics. He is very interested in music and the arts and is himself a keen practising musician.

He is a member of the Council of St. Hilda's Church of England School and Vice-Chairman of St. Catherine's Council, University of Western Australia. He is also a member of the Australian College of Education.

Mr. King is married with two sons and a daughter. One of his sons, Mr. F.W. King, is a Lecturer in the Department of English. Mr. King took up his appointment in February.

#### CHAIR OF HISTORY

Dr. Alan McBriar has been appointed to a Chair of History. He was previously Reader in History in the University of Melbourne.

Dr. McBriar is a graduate of the University of Melbourne and of Oxford University. On an Aitchison Travelling Scholarship he went to Balliol College, Oxford, and was awarded a D.Phil. in 1949.

His research has been in British History of the period 1880-1918. His book 'Fabian Socialism and English Politics' 1884-1918, (C.U.P. 1962), is highly regarded, and a second edition and paperback edition have appeared this year. He is at present engaged in writing a book on Edwardian England, with the Royal Commission on the Poor Laws 1905-9 as a focal point of the study. He wrote a chapter on 'The Webbs and their Work' ed. Margaret Cole (Frederick Muller, London 1949) and from 1949 to 1955 and again in 1958 he edited the journal 'Historical Studies, Australia and New Zealand'. Dr. McBriar, who is married, took up his appointment in January.

#### APPOINTMENT OF ASSISTANT REGISTRARS

Mr. V.G. Brownie and Mr. K.J. Farrer have been appointed Assistant Registrars.

Mr. Brownie will be responsible to the Academic Registrar for the conduct of the affairs of the Professorial Board and its Committees in the main.

Mr. Farrer will be responsible to the Academic Registrar for the conduct of the affairs of the Committee of Deans and Library Committee primarily.

#### AFFILIATION BETWEEN MONASH AND THE BAKER MEDICAL RESEARCH INSTITUTE

The formal signing of an agreement of affiliation between the Baker Medical Research Institute and Monash took place last December.

The Baker Medical Research Institute was originally founded in 1926 by the late Thomas Baker (of Kodak) on behalf of himself, his wife Alice Baker, and his sister-in-law Eleanor Shaw, as the Bio-chemical Laboratory at Alfred Hospital.

Subsequently this Laboratory developed into an institute for medical research and has won world recognition, first under Dr. W.J. Penfold and currently under Dr. T.E. Lowe, for its work in heart, cancer, and blood research.

For Monash, part of whose medical school is situated adjoining the Baker Medical Research Institute, the affiliation means that the research facilities of the Institute are fully available for the teaching of both undergraduate medical students and postgraduate students of the University. The affiliation makes possible the complete integration of the trained personnel and facilities of the University and the Institute for the benefit of medical education and research.

#### WORLD UNIVERSITY SERVICE

World University Service in Australia wishes to thank members of staff for their response to their recent appeal for funds. \$636 was received from Melbourne University and \$268 from Monash. Where especially requested, the money will be used for the Union Building, University of Papua New Guinea. The rest has become part of the international fund, used for helping universities throughout the world.

#### STAFF DRAMA GROUP

The Staff Drama Group's first function for 1966 will be an Elizabethan evening to be held in the Union Hall on Tuesday, 1st March. The programme, which has been assembled by Harold Love, will consist of a suitably festive selection of prose, verse and music of the late sixteenth and early seventeenth centuries, including an authentic Elizabethan sermon against drunkenness to be delivered by Dennis Davison. The music will include pieces for voices, recorders, strings and crumhorn. During the interval, the audience will be invited to join the performers for a glass of genuine Elizabethan hypocras. Admission will be 30 cents, the proceeds going to the Monash Pre-School Centre.

The first of the regular monthly play-reading evenings for 1966 is to be held on Monday, 7th March. Instead of a play-reading, however, there is to be a talk on recent theatre in London, by David Bradley of the English Department. This evening will not be held in the English Department Library, but at the home of Mr. and Mrs. Dobson, 60 Middlesex Road, Surrey Hills. It will begin at 8 p.m. All members of staff and their friends are welcome to attend.

Subsequent activities planned by the group include a major production during the week beginning 18th April, and a series of lunch-time acted-readings in the Union Hall. Details of these activities will appear in the next edition of the Monash Reporter. In the meantime, however, the Secretary of the group (Betty Moore, English Department, extension 2140) will be pleased to hear from any member of staff, academic or otherwise who is interested in any aspect of theatre, whether it be acting, set designing, scene painting or costume making.

#### CHAPLAIN

The Rev'd. L.W. Hahn has been appointed Chaplain to students of Christian denominations other than Roman Catholic. Mr. Hahn served in the Merchant Navy for four years before attending St. John's College, Morpeth, for his theological training. Upon ordination he served on the St. George's Cathedral Staff, Perth; was Acting Chaplain/Teacher on the Forest River Aboriginal Mission, North West Australia, and Vicar of Wongan Hills in the wheat-belt of Western Australia.

From there he joined the Hospital Chaplaincy Staff in the Diocese of Melbourne, and was Chaplain in the Royal Melbourne and Prince Henry's General Hospitals and later in Kew and Ballarat Mental Hospitals.

In 1960 Mr. Hahn went to the U.S.A. on the Howard Chandler Robbins Fellowship and a World Council of Churches Exchanges Scholarship. He worked and studied in St. Elizabeth's Hospital, Washington and the Wesley Theological Seminary. Concurrently with his hospital work he took out the degree of Master of Sacred Theology and received the Shea Award in Pastoral Theology.

Since his return to Australia he has been Chaplain to Mont Park, Plenty and Larundel Hospitals. He has also been engaged in the selection and training of theological students and Post Ordination Training and Schools of Pastoral Care in Australia and New Zealand. Mr. Hahn is married with three children.

MR. M. DEUTSCHER

Mr. M.J. Deutscher, a Senior Lecturer in the Department of Philosophy since 1964, has accepted the Chair of Philosophy at Macquarie University, New South Wales.

Mr. Deutscher graduated B.A. from the University of Adelaide and B.Phil. from Oxford University. In 1962 he held a joint lectureship at Trinity and Exeter Colleges, Oxford.

He has published articles in 'Mind', 'Analysis' and in the Australian Journal of Philosophy. He contributed a chapter on Descartes in 'Early Seventeenth Century Scientists' edited by R. Harre, the Lecturer in Scientific Method at Oxford, published by Oxford Pergamon Press, 1965.

Mr. Deutscher's research interests have been in the philosophy of science and philosophical psychology.

STAFF-STUDENT CONFERENCE - 1966

Last year a three day residential conference on problems of transition was held in the final week of the first term vacation. Seventy one students and fifteen members of staff participated in this conference which took the form of small discussion groups covering a wide variety of topics. Those who took part felt it was a valuable experience and some staff members felt that they gained even more than the students.

A similar conference is planned for 1966, but on a larger scale. As a preliminary, the Student Counsellor would like to organize discussion groups amongst staff members. Broadly, these discussions would cover the problems involved in the transition from school to the University, study and organization difficulties encountered by the student, the teacher-student relationship and its effect on learning. Participation in these groups would not necessarily involve the staff member in the actual conference. One disappointing feature of the 1965 conference was the absence of junior members of staff. We should very much like to see some taking part this year.

## LUNCH HOUR CONCERT

The Department of Music will organize and present a regular series of free lunch-hour concerts throughout this year. The concerts are open to all students and staff of the University, and will take place from 1.10 p.m. to 2 p.m. in the Union Theatre every Monday during terms, commencing on March 21st. Thanks to a financial grant for this purpose from the Vice-Chancellor, it has been possible to engage a number of prominent professional musicians for these concerts, and only a few programmes will make use of recordings. It is also hoped to include several recitals by musical societies or individual performers within the University.

Three "series" within the overall season for 1966 have been planned: six pianoforte recitals by Michael Brimer, the recently arrived Senior Lecturer in Music, will survey the development of pianoforte music in the nineteenth century, beginning with Beethoven's "Hammerklavier" Sonata at the inaugural concert on March 21st, which will also mark the first public appearance of the University's new Yamaha grand piano. Mr. Brimer is one of the most brilliant pianists and organists ever to work in this country. His recitals in Perth during the last four years and his success in establishing the outstanding West Australian Bach Society as the finest choir in Australia have earned him a nation wide reputation.

In three recitals the Ormond Trio will present a cross-section of music for piano, violin and 'cello, and a further series of three programmes will encompass the complete music for violin and piano by Brahms, in which each of the three sonatas will be played by a different violinist. Artists so far engaged for these and other concerts include Leonard Dommett, Sybil Copeland and John Glickman (violinists), Max Cooke and Margaret Schofield (pianists), Brian Hansford (baritone) and the Paul McDermott String Quartet.

1966 will see the Department's first full year of operation, and the offering of the first course in music at Monash, Music I, which will be followed in each succeeding year by subsequent units up to a full honours sequence. A "music laboratory" is being installed to cater for the listening needs of music students, and considerable use will be made in this laboratory of programmed instructional material on magnetic tapes.

Research in the Department has already commenced with the appointment to a Research Fellowship in Australian Aboriginal music of Mrs. Alice M. Moyle, under financial arrangements made with the Australian Institute of Aboriginal Studies in Canberra, and an Ethnomusicology Section of the Institute is being established within the Department under her guidance.

Practical music-making by the Department has been facilitated by the recent decision of the Choral Society and the Orchestral Society of the University to invite the Department to supply conductors for their performing groups. As a result of this move it is hoped that a cordial and mutually beneficial relationship will emerge from the outset and quickly grow between these student musical societies and the Music Department.

Recent and forthcoming performances of compositions by Professor Trevor Jones include the "Cantata Zoologica" for mixed chorus and wind quintet by the W.A. Bach Society Choir in the current Festival of Perth, the "Four Goliard Songs" by the Leonine Consort of Sydney, and the "Dylan Thomas Elegy" by a choir at the University of New South Wales.

#### MONASH FILM GROUP

#### CLERICAL STAFF ASSOCIATION

On the 18th December at the Australian National University, Canberra, representatives of non-academic staff associations from nearly all Australian universities met to discuss the formation of a federal body. Monash was represented by the President of the Clerical Staff Association, Mr. C. Stokes.

A Federal Committee of eight members was formed and Mr. Stokes was elected to the Committee. The Committee which met in Sydney on the 14th February has asked all universities to vote on the following by the 1st July this year:

1. That the Federal Committee elected at Canberra in 1965 be recognized as the Commonwealth Council of University non-academic staff associations which shall carry out the decisions of Canberra as ratified by the various staff associations.
2. That a further convention be held in December this year in Canberra, with voting rights on the basis of two (2) representatives per university.

The clerical staff at Monash will be voting but the Federal Committee also represents the technical staff in nearly all universities except Monash and Mr. Stokes would like to hear from members of the technical staff interested in forming a technical division of the association at Monash and being represented at the next conference.

A further cheque for \$140 has been received for the Great Hall Appeal from the performance of the 'Student Prince' in the Malvern Town Hall last November arranged by the Clerical Staff Association. Total receipts were \$1,230 and expenses \$390 leaving a net profit of \$840 raised for the Appeal. This is a very considerable amount to raise from one function and the success is due to the many members of staff who gave their support.

#### GIFTS

A grant of \$50,000 from the Wellcome Trust in London will enable facilities at the Monash Medical School, Alfred Hospital to be extended by the erection of additional accommodation on the roof of the Medical School Building, to serve the research needs of the departments of Microbiology, Medicine, Surgery and Pathology. Infectious hepatitis, the metabolism of the heart, problems of wound healing, and the immunology of cancer are some of the research projects which will be aided by the improved facilities.

\$600 has been received by Associate Professor Elwyn Morey, Faculty of Education, towards the establishment of a Child Study Centre from Mr. and Mrs. H. Goodman of Kew.

\$500 has been received by the Department of Civil Engineering from James Hardie and Co. Pty. Ltd. This is the first of three annual donations towards the cost of equipment for a basic research study of the action of expansive clays on buried structures.

Ford Motor Company have provided \$222 to the Department of Mechanical Engineering for its Combustion Engine Laboratory.

#### FIELD DAYS

The Local Government Engineers' Association of Victoria conducted Field Days at the University on Tuesday 22nd and Wednesday 23rd February. Earth-moving and road-making equipment was displayed by various manufacturers to municipal engineers and their councillors, and to contractors engaged in local government work. In displaying the different types of equipment, the University has benefited from these Field Days because the demonstrations of the \$3-4 million worth of equipment have resulted in excavation for a hockey field, a car-park overlooking the sports ground, and a future road.

#### MRS. MARGARET DOBSON

The University learned with deep sorrow of the death of Mrs. Margaret Dobson who was killed in a motor accident on Monday 20th December.

Mrs. Dobson, who worked in Central Services, Administration, had been at Monash for two years. She is survived by two children.

#### MR. JOHN TILLE

The University learned with deep sorrow of the death of Mr. John Tille, who disappeared while skin-diving on Wednesday 22nd December.

Mr. Tille, who was a Senior Teaching Fellow in the Department of Physiology, had been at Monash for two years.

## STAFF ARRIVALS

The following is the list of staff arrivals to the end of January.

Associate Professor C. Mc Coy - Visiting Lecturer in the Department of Politics from February to September. Associate Professor Mc Coy is Associate Professor of Political Science at Temple University, Philadelphia, and is giving a series of lectures on American Politics. He also hopes to continue his research into voting patterns in Australia.

Mr. G. Betts - Senior Lecturer in Classical Studies - graduated B.A. in 1954 from the University of Sydney, winning the University Medal in Latin, and M.A. in 1964 from the University of Cambridge. In 1958 he took a lectureship in University of Newcastle where he remained until last year. His main research activity is in Sanskrit and Greek Drama, and he is at present preparing a commentary on Euripides 'Hecuba'. Mr. Betts is married.

Mr. H.B. Connell - Senior Lecturer in Law - graduated B.A. (Hons.) in 1949 and Dip.Ed. in 1954 from the University of Melbourne. From 1951 - 1957 he taught history at Geelong Church of England Grammar School and from 1958 - 1960 he was Resident Tutor at Trinity College, Melbourne while completing an LL.B. at the University of Melbourne. Before coming to Monash, Mr. Connell was Senior Legal Officer in the Attorney General's Department. He is married with four children.

Mr. W.G. Cook - Senior Lecturer in Accounting - graduated B.Com. from the University of Melbourne in 1957. The following year he passed the preliminary examination for M. Com. while working as a tutor at the same University. In 1960 he accepted an appointment as Lecturer in Accountancy at the University of New South Wales. While holding this full-time post he completed an LL.B. degree at the University of Sydney. Mr. Cook's research interests are in taxable income as contrasted with the accountant's concept of profit and taxation in relation to fiscal policy. He is married with three children.

Dr. M.J. Englefield - Senior Lecturer in Mathematics - graduated B.Sc.Hons. from the University of Southampton in 1953 and Ph.D. from the same university in 1956. Prior to taking up an appointment as lecturer in Mathematics at the University College of North Wales, he worked for a year as a research associate in the Ames Laboratory of the United States Atomic Energy Commission.
